

Notice of Intended Sale

Notice of intended sale under Rule 6 [2] and 8 [6] of the Security Interest [Enforcement Rules] 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002.

Sri P Siva S/o Venkataiah & Sri P Eswar S/o Venkataiah availed the above cited facility/ies from Saptagiri Grameena Bank, NGO's Colony Branch, the repayment of which is secured by mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Sri P Siva (Borrower & Mortgager) 1st of the above, Sri P Eswar (Borrower/Mortgager/Guarantor) 2nd of the above failed to pay the outstanding. Therefore a Demand Notice dated 22.08.2023 under Sec 13 [2] of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 [for short called as "The Act"], was issued by the Authorized officer calling upon Sri P Siva S/o Venkataiah & Sri P Eswar S/o Venkataiah liable to the Bank to pay the amount due to the tune of Rs.78,41,742/- [Rupees Seventy Eight Lakh Forty One Thousand Seven Hundred and Forty two only] balance as on 22.08.2023 with further interest, costs, other charges and expenses thereon. Sri P Siva & Sri P Eswar failed to make payment despite demand notice dated 22.08.2023.

As Sri P Siva & Sri P Eswar and others failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 23.11.2023 after complying with all legal formalities.

As per Sec.13 [4] of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the Authorized Officer intends selling the schedule mentioned securities in any of the following mode: a. By inviting tenders from public or b. By holding public auction or c. By private treaty.

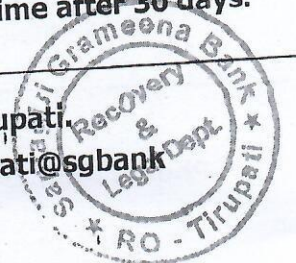
