

- 3. Evidence of date of birth either from the SSC mark sheet or birth certificate or its equivalent thereof, issued by the Competent Authority.
- 4. Comprehensive Certificate of physical fitness in the enclosed form, from a qualified Doctor of rank not less than that of a **Civil Surgeon** (Govt. Doctor).
- 5. Five copies of your recent passport size colour photograph.
- 6. No objection certificate from the previous employer, if already employed.
- 7. Caste / Category certificate issued by Competent Authority in the prescribed format as stipulated by Govt., of India in case of Scheduled Caste / Scheduled Tribes / OBC / PWD category candidates. In case of candidates belonging to OBC category, certificate obtained after 01.04.2024 should specifically contain a clause that the candidate does not belong to creamy layer section.
